
In continuation of this Ministry's letter of even number dated 23.06.2009 and in pursuance of order dated 08.07.2010 passed by the Hon'ble High Court of Madhya Pradesh at Indore, the Dental Council of India deputed their Inspectors, namely, Dr Vivek Hegde, Pune and Dr. Sharad Karnat, Bagalkot, to verify the compliance report dated 10.05.2010 submitted by college authorities. The Inspectors inspected the subject dental college on 15.07.2010 and submitted their report to the Council on 16.07.2010. The EC of DCI considered the matter by circulation on 19.07.2010 and recommended to the Central Government to renew its permission for admitting the 5th batch of students in BDS course with 100 seats at Sri Aurobindo College of Dentistry, Indore for the academic session 2010-11, after giving relaxation of 5% in teaching faculty from 3rd year onwards in the dental colleges.

2. As per the recommendation of the Dental Council of India, the permission of the Central Government is granted to the Sri Aurobindo College of Dentistry for admission of 100 students as the 5th batch for the academic year 2010-11. However, since the last date for grant of such permission has already expired on 15.07.2010, the above Central Government permission to the Institute is subject to the condition that the Institute obtains the orders of Supreme Court to the effect that such permission would not violate the earlier order of the Hon'ble Supreme Court to the effect that 15th July would be last date for grant such permission in the relevant academic year.

3. Admissions made in violation of the above conditions will be treated as irregular and action under Section 10B of the Dentists (Amendment) Act, 1993 will be initiated.


4. This Letter of Intent is subject to fulfilment of the following conditions:
